## 2025 - 2026 Afterschool Programming



<u>PROGRAM FORMAT</u>: Our Afterschool programs are offered to <u>Civic Center members only</u> and provide a structured environment for children after school. Both programs are for students in Kindergarten through 5<sup>th</sup> grade in the Wahoo area. All children from any area school are eligible to participate. However, keep in mind, these programs will be aligned with the Wahoo Public Schools calendar.

Homework Club: This is a weekly program held Monday through Friday from 3:40pm-4:00pm. The program is provided for students to receive homework assistance immediately after school. Parents may leave a snack for their children.

<u>"Dayz" Programs</u>: These daily programs are held from 4:00pm-6:00pm and have a different activity or theme each day. If necessary, an alternative activity may be held as needed. Children can enroll in one day, multiple days, or every day! The specific activity or theme each day will be as follows: Mondays – Gym Dayz Tuesdays – Craft Dayz Wednesdays – Swimming Dayz Thursday – Art Dayz Friday – Movie Dayz

<u>FEE STRUCTURE</u>: Homework Club: \$18.75/student per week Dayz Programs: \$5.50/student per day Payments for all programs must be made via bank draft from a checking or savings account. Payments will be processed on (or around) the 15<sup>th</sup> of each month. Complete the attached ACH authorization form as part of the registration process.
